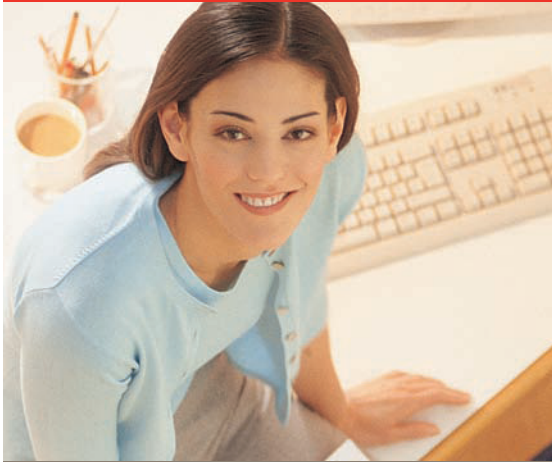

Scotiabank Peru S.A.A. started its operations in Peru on May 13th, 2006, as a result of the integration of Banco Wiese Sudameris and Banco Sudamericano, both well known institutions in the country.

However, Scotiabank's presence in Peru goes back to 1997, when it became a shareholder of Banco Sudamericano, with a participation of 35%. On March 9, 2006, the Canadian group increased its participation to 100%, becoming the only shareholder. As part of an expansion strategy in Latin America, on the same day, March 9th, 2006, Scotiabank acquired a majority participation, approximately 77%, of the shares owned by Banca Intesa S.p.A., in Banco Wiese Sudameris. Scotiabank subsequently purchased Banca Intesa's remaining interest in the bank, and as of April 30, 2009, Scotiabank, owns directly and indirectly 97.66% of Scotiabank Peru S.A.A.

Scotiabank Peru, as the third largest bank with 170 branches, provides extensive coverage nationwide and has one of the most complete virtual networks in the country, which when added to the capacity of our employees, allows the Bank to offer very high quality services to its clients.

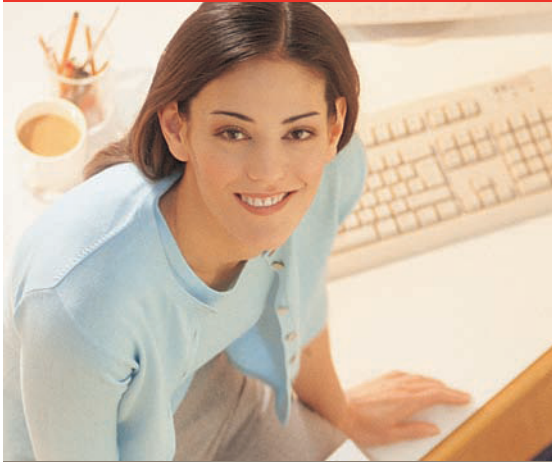
