

Terms and Conditions

OFFICIAL RULES

The transaction must be a purchase paid with a ScotiaCard. Required minimum purchase is ANG 20.

ELIGIBILITY

This promotion is open to legal residents of St. Maarten, 18 years of age or older, with the exception of employees of Scotiabank (hereinafter referred to as "The Bank") and its respective parent companies, subsidiaries and/or those living in the same household of each and their immediate families (spouses, parents, children and siblings and their respective spouses), its advertising agency, and/or those living in the same household of each. CONSUMER DISCLOSURE

Only purchases posted to ScotiaCard accounts between November 15, 2009 and January 31, 2010 will be entered into the draw. The minimum purchase is ANG 20 and each purchase during the promotion period will represent a chance to win. Cash advances, interest charges, service charges or annual membership fees do not qualify as purchase transactions. Transactions must be processed by The Bank to qualify. Transactions must be posted to the ScotiaCard account on or before January 31, 2010. Transactions posted to the ScotiaCard account after January 31, 2010 do not qualify.
