

# Scotiabank 2010 FIFA World Cup Promotion

## Official Rules & Regulations

### OFFICIAL RULES

1. Only customers with a valid Scotiabank Visa credit card or ScotiaCard Visa Debit card are eligible to enter. Cardholders may enter as many times as they wish, so long as they make a minimum purchase of \$25 BSD each time.
2. Eligible transactions must be retail purchases made using a Scotiabank Visa credit card or ScotiaCard, credit card cheque usage or a balance transfer made using a Scotiabank Visa credit card. Eligible purchases can be made at Point of Sale in person, online, by mail or telephone order. Purchases made with a corporate or business credit card are not eligible.
3. Visa Credit Card cash advances from an (ATM or teller); service charges, annual membership fees, interest charges and account credit/adjustment transactions are not eligible for entry. Withdrawals or other transaction made at the branch or ATM using ScotiaCard is not eligible.
4. All transactions must be processed by Scotiabank to qualify and must be posted to the credit card or ScotiaCard account between February 1 and March 31, 2010.
5. The loss of a customer's credit or Debit card after he or she has submitted an entry into the Promotion does not void the entry, unless the customer did not report the card as being lost or stolen.
6. The prizes are not transferable and are subject to change at the sole discretion of Scotiabank, but with prior consultation with Scotiabank (Bahamas) Ltd. The prize must be accepted as awarded. No substitutions are available nor will there be any substitutions for any cash value.
