1832 Asset Management L.P. is the manager (the "Manager") of the fund. In this document, "we", "us", "our" and the "Manager" refer to 1832 Asset Management L.P. and the "Fund" refers to Scotia Global Growth Fund.

The term "net asset value" or "net asset value per unit" in this document refers to the net asset value determined in accordance with Part 14 of National Instrument 81-106 – Investment Fund Continuous Disclosure ("National Instrument 81-106"); while the term "net assets" or "net assets per unit" refers to total equity or net assets attributable to unitholders of the Fund as determined in accordance with International Financial Reporting Standards ("IFRS").

Results of Operations

For the six month period ended June 30, 2018 (the "period"), the Series A units of the Fund returned 7.7%. Fund returns are reported net of all management fees and expenses for all series, unlike the returns of the Fund's benchmark, which is based on the performance of an index that does not pay fees or incur expenses. Returns for other series of the Fund will be similar to Series A units with any difference in performance being primarily due to different management fees, operating expenses and other expenses that are applicable to that particular series. Please see the "Past Performance" section for the performance of the Fund's other series.

The Fund's broad-based benchmark, the MSCI All Country World Index (C\$), returned 4.3% during the same period. In accordance with National Instrument 81-106, we have included a comparison to this broad-based index to help you understand the Fund's performance relative to the general performance of the market.

The Fund outperformed its broad-based benchmark as a result of stock selection, with a number of larger holdings within the portfolio delivering strong operational progress that was rewarded by the market.

In the first half of 2018, global equity market volatility increased, driven by U.S. inflation concerns, trade tensions and political uncertainty. For the most part, however, companies with strong

operational progress continued to benefit from higher share prices. The Fund's overall outperformance reflects the fact that the majority of portfolio holdings delivered strong results.

From a regional perspective, stock selection in North America was the largest contributor to the Fund's performance. Consumer Discretionary was the top sector contributor, largely driven by the Fund's large position in Amazon.com Inc. Amazon's share price continued to perform strongly over the period, largely as a result of operational progress. The company added more prime members in 2017 than in any previous year, and it continues to rapidly grow its web services business. We are encouraged by recent progress and remain positive about the company's long-term prospects.

ABIOMED Inc. and GrubHub Inc. also contributed to the Fund's performance. ABIOMED is the U.S. designer and manufacturer of the temporary heart pump, Impella. The company performed well as the number of patients able to benefit from its heart pump increased sharply following updated approvals from the U.S. Food and Drug Administration. The pump has also seen solid take-up overseas, with both German and Japanese volumes growing strongly. GrubHub is a U.S. online food delivery platform. The company has been building impressive scale and its share price has been rewarded. It now offers access to more than 80,000 restaurants in 1,600 cities in the U.S. and is four times the size of its nearest competitor. A recent deal with Yum! Brands Inc. to be the exclusive delivery partner for Taco Bell and KFC has helped cement GrubHub's progress.

From a regional perspective, stock selection among U.K. equities detracted most from performance, particularly the Fund's holding in insurer Prudential PLC. An underweight position in the strong North American market detracted, although this was offset by strong stock selection. At the country level, stock selection in Denmark detracted, driven by holdings in container shipping company A.P. Moller-Maersk A/S and biotechnology firm Genmab A/S. However, we remain positive about the long-term outlook for both companies. Naspers Ltd. detracted from performance. Its share price fell following the announcement of its intention to sell part of its stake in Chinese social media platform Tencent Holdings Ltd. The sale reduced Naspers' holding from 33% to 31%.

Signify NV (formerly Philips Lighting) also detracted as its share price weakened. Market concerns remain around the sustainability of its traditional lighting business, which still contributes about a third of revenues. Signify has been out of favour with the market.

In keeping with our long-term outlook, the Fund's portfolio turnover remains low at approximately 20% per year. As such, the composition of the portfolio is largely consistent with the prior year. However, we have increased the Fund's allocation to earlier-stage platform businesses, including LendingTree Inc., Zillow Inc. and Netflix Inc. We have also increased the Fund's allocation to businesses with reward profiles that we believe are likely to be uncorrelated to that of the current portfolio. These include mining services company Orica Ltd., lithium producer Albemarle Corp. and mining conglomerate BHP Billiton Ltd.

We are mindful of valuations following a prolonged period of strong performance for the global equity market and the Fund. We have therefore reduced a number of positions on share price strength, where holdings in the Fund have become large, or where we feel that the market view is now less differentiated from our own. These include Amazon.com, Naspers and Alphabet Inc. The proceeds from these sales were used to purchase earlier-stage platform businesses.

The Fund's net asset value increased by 8.6% to \$1,158.1 million at June 30, 2018, from \$1,066.8 million at December 31, 2017. This change was composed of net redemptions of \$1.6 million and investment performance of the Fund of \$92.9 million. The investment performance of the Fund includes income and expenses which vary year over year. The Fund's income and expenses changed compared to the previous year mainly as a result of fluctuations in average net assets, portfolio activity and changes in the Fund's income earning investments.

Certain series of the Fund, as applicable, may make distributions at a rate determined by the Manager from time to time. If the aggregate amount of distributions in such series exceeds the portion of net income and net realized capital gains allocated to such series, the excess will constitute a return of capital. The Manager does not believe that the return of capital distributions made by such series of the Fund have a meaningful impact on the Fund's ability to implement its investment strategy or to fulfill its investment objective.

Recent Developments

IFRS 9, Financial Instruments

The Funds have adopted IFRS 9, Financial Instruments in the current reporting period commencing January 1, 2018. The adoption of IFRS 9 has been applied retrospectively and does not result in a change to the classification or measurement of financial instruments, in either the current or prior period.

The impact to the Fund will include additional disclosures related to changes to the classification of certain financial instruments to align with the classifications under IFRS 9. Adoption of the standard does not impact net assets attributable to holders of redeemable units.

Related Party Transactions

The Manager is a wholly-owned subsidiary of The Bank of Nova Scotia ("Scotiabank"). Scotiabank also owns, directly or indirectly, 100% of Scotia Securities Inc. and Tangerine Investment Funds Limited, each a mutual fund dealer, and Scotia Capital Inc. (which includes ScotiaMcLeod and Scotia iTRADE), an investment dealer.

The Manager, on behalf of the Fund, may enter into transactions or arrangements with other members of Scotiabank or certain other companies that are related or connected to the Manager (each a "related party"). All transactions between the Fund and the related parties are in the normal course of business and are carried out at arm's length terms.

The purpose of this section is to provide a brief description of any transaction involving the Fund and a related party.

Management Fees

The Manager is responsible for the day-to-day management and operations of the Fund. Certain series of the Fund pay the Manager a management fee for its services as described in the “Management Fee” section later in this document. The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and paid monthly.

Fixed Administration Fees and Other Fund Costs

The Manager pays the operating expenses of the Fund, other than Fund Costs, in exchange for the payment by the Fund of a fixed rate administration fee (the “Fixed Administration Fee”) to the Manager with respect to each series of the Fund, other than Advisor Series and Series F. The expenses charged to the Fund in respect of the Fixed Administration Fee are disclosed in the Fund’s financial statements. The Fixed Administration Fee is equal to a specified percentage of the net asset value of a series, calculated and paid in the same manner as the management fees for the Fund. Further details about the Administration Fee can be found in the Fund’s most recent simplified prospectus.

Where applicable, the Advisor Series and Series F of the Fund paid its proportionate share of the Fund’s operating expenses that are common to all Series throughout the period.

In addition, each series of the Fund is responsible for its proportionate share of certain operating expenses (“Other Fund Costs”). Further details about Other Fund Costs can be found in the Fund’s most recent simplified prospectus.

The Manager, at its sole discretion, may waive or absorb a portion of a series’ expenses. These waivers or absorptions may be terminated at any time without notice.

Distribution Services

Certain registered dealers through which units of the Fund are distributed are related parties to the Fund and the Manager. The Manager may pay to these related parties a trailer commission out of its management fees, representing distribution and servicing fees, based on the amount of assets held in the investors’ accounts. These fees are paid on the same basis and at the same rates that the Manager pays to non-affiliated dealers.

Other Fees

The Manager, or its affiliates, may earn fees and spreads in connection with various services provided to, or transactions with, the Fund, such as banking, custody, brokerage, foreign exchange and derivatives transactions. The Manager, or its affiliates, may earn a foreign exchange spread when unitholders switch between series of funds denominated in different currencies.

Independent Review Committee

The Manager has established an independent review committee (the “IRC”) in accordance with National Instrument 81-107 –

Independent Review Committee for Investment Funds (“NI 81-107”) with a mandate to review and provide recommendations or approval, as required, on conflict of interest matters referred to it by the Manager on behalf of the Fund. The IRC is responsible for overseeing the Manager’s decisions in situations where the Manager is faced with any present or perceived conflicts of interest, all in accordance with NI 81-107.

The IRC may also approve certain mergers between the Fund and other funds, and any change of the auditor of the Fund. Subject to any corporate and securities law requirements, no securityholder approval will be obtained in such circumstances, but you will be sent a written notice at least 60 days before the effective date of any such transaction or change of auditor. In certain circumstances, securityholder approval may be required to approve certain mergers.

The IRC has five members, Carol S. Perry (Chair), Stephen J. Griggs, Simon Hitzig, Heather A. T. Hunter and Jennifer L. Witterick, each of whom is independent of the Manager. On April 30, 2018, Brahm Gelfand and D. Murray Paton resigned as members of the IRC. On May 15, 2018, the IRC appointed Mr. Griggs and Ms. Hunter as members.

The IRC prepares and files a report to the securityholders each fiscal year that describes the IRC and its activities for securityholders as well as contains a complete list of the standing instructions. These standing instructions enable the Manager to act in a particular conflict of interest matter on a continuing basis provided the Manager complies with its policies and procedures established to address that conflict of interest matter and reports periodically to the IRC on the matter. This report to the securityholders is available on the Manager’s website or, at no cost, by contacting the Manager.

The compensation and other reasonable expenses of the IRC will be paid out of the assets of the Fund as well as out of the assets of the other investment funds for which the IRC may act as the independent review committee. The main components of compensation are an annual retainer and a fee for each committee meeting attended. The chair of the IRC is entitled to an additional fee. Expenses of the IRC may include premiums for insurance coverage, travel expenses and reasonable out-of-pocket expenses.

The Fund received the following standing instructions from the IRC with respect to related party transactions:

- Paying brokerage commissions and spreads to a related party for effecting security transactions on an agency and principal basis on behalf of the Fund;
- Purchases or sales of securities of an issuer from or to another investment fund managed by the Manager;
- Investments in the securities of issuers for which a related underwriter acted as an underwriter during the distribution of such securities and the 60-day period following the completion of such distribution;
- Executing foreign exchange transactions with a related party on behalf of the Fund;

- Purchases of securities of a related party;
- Entering into over-the-counter derivatives on behalf of the Fund with a related party;
- Outsourcing products and services to related parties which can be charged to the Fund;
- Acquisition of prohibited securities as defined by securities regulations;
- Trading in mortgages with a related party.

respect to a related party transaction: (a) is made by the Manager free from any influence by an entity related to the Manager and without taking into account any consideration to any associate or affiliate of the Manager; (b) represents the business judgment of the Manager uninfluenced by considerations other than the best interests of the Fund; and (c) is made in compliance with the Manager's written policies and procedures. Transactions made by the Manager under the standing instructions are subsequently reviewed by the IRC to monitor compliance.

The Fund relied on IRC standing instructions regarding related party transactions during the period.

The Manager is required to advise the IRC of any breach of a condition of the standing instructions. The standing instructions require, among other things, that the investment decision in

⁽⁴⁾ The Fund's portfolio turnover rate indicates how actively the Fund's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the period. The higher a fund's portfolio turnover rate in a period, the greater the trading costs payable by the fund in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

Management Fees

The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and paid monthly. The management fees cover the costs of managing the Fund, arranging for investment analysis, recommendations and investment decision making for the Fund, arranging for distribution of the Fund, marketing and promotion of the Fund and providing or arranging for other services.





Year-by-Year Returns




