1832 Asset Management L.P. is the manager (the "Manager") of the fund. In this document, "we", "us", "our" and the "Manager" refer to 1832 Asset Management L.P. and the "Fund" refers to DynamicEdge Defensive Portfolio.

The term "net asset value" or "net asset value per unit" in this document refers to the net asset value determined in accordance with Part 14 of National Instrument 81-106 – Investment Fund Continuous Disclosure ("National Instrument 81-106"); while the term "net assets" or "net assets per unit" refers to total equity or net assets attributable to unitholders of the Fund as determined in accordance with International Financial Reporting Standards ("IFRS").

Results of Operations

For the six month period ended at December 31, 2016 (the "period"), the Series A units of the Fund returned 0.7%. Fund returns are reported net of all management fees and expenses for all series, unlike the returns of the Fund's benchmark, which is based on the performance of an index that does not pay fees or incur expenses. Returns for other series of the Fund will be similar to Series A with any difference in performance being primarily due to different management fees, operating expenses and other expenses that are applicable to that particular series. Please see the "Past Performance" section for the performance of the Fund's other series.

The Fund's broad-based benchmarks, the FTSE TMX Canada Universe Bond Index and the S&P/TSX Composite Index, returned -2.3% and 10.2%, respectively, during the same period. In accordance with National Instrument 81-106, we have included a comparison to broad-based indices to help you understand the Fund's performance relative to the general

performance of the market, but caution that the Fund's mandate may be significantly different from the indices shown.

The Fund's blended benchmark, 7% S&P/TSX Composite Index, 13% MSCI World Index (C\$) and 80% FTSE TMX Canada Universe Bond Index, returned 0.1% during the same period. We have included this comparison, which more closely reflects the market sectors and/or asset classes in which the Fund invests, to provide a more useful comparative to the performance of the Fund.

To achieve its long term asset allocation mandate, the Fund invests directly in funds managed by the Manager ("Underlying Funds"). As a result, the following commentary on investment portfolio activity relates to the Underlying Funds. Commentary on income, expenses and unitholder activity relate to the Fund.

The Fund has a long-term asset allocation of 20% equity (7% Canadian, 13% global) and 80% bonds. The Fund outperformed its blended benchmark as the fixed income component outperformed its index the FTSE TMX Canada Universe Bond Index and offset a lag from the Canadian and global equity components.

The Canadian bond market represented by the FTSE TMX Canada Universe Bond Index lost 2.3% as yields increased over the second half of the year. Corporate bonds (-0.3%) fell much less than government bonds (-3.0%) during the period. Canadian long-term bonds (10+ years) were hit especially hard returning -5.3% in the last 6-months. Fueled by a continued recovery in the oil and gas industry, high-yield bonds as represented by the Bloomberg Barclays U.S. High Yield Very Liquid Index (C\$, Hedged) returned +7.0%. In the fixed income component, the strongest return came from Dynamic Credit Spectrum Fund which focuses on higher yielding securities. Notably, in a negative environment for fixed income, Dynamic Investment Grade Floating Rate Fund and Dynamic Short Term Bond Fund gained ground, provided diversification and helped protect the Fund against the possibility of rising rates. Dynamic Strategic Bond Fund and Dynamic Corporate Bond Strategies Fund also gained ground helped by exposure to corporate bonds and lower relative duration. Finally, Dynamic Canadian Bond Fund, which has the largest fixed income allocation, and Dynamic Aurion Total Return Bond Fund, lost ground over the period but outperformed the index. As a result, the combined weighted return of the funds in the bond component outperformed the FTSE TMX Canada Universe Bond Index.

The Canadian equity market rallied in the second half of the year gaining 10.2%. During the period, the strongest returns came from Financials (+18.1%), followed by Industrials (+16.6%) and Energy (+13.6%). Materials (-7.3%) experienced a setback after making significant gains in the first half of the year when commodity prices rebounded off the lows. Health Care, which is a very small weight in the index, had the lowest return for the period (-22.1%). Income-oriented securities outperformed as the S&P/TSX Equity Income Index finished up 12.0% while Canadian small-cap stocks represented by the BMO Blended Small Cap Weighted Index (+9.6%) performed in line with the broad equity

market. In the Canadian equity component, Dynamic Power Canadian Growth Fund helped by favourable security selection in the Energy sector had the strongest returns and outperformed the index. The remaining funds in the Canadian equity component (Dynamic Dividend Fund and Dynamic Value Fund of Canada) also gained ground but underperformed the index mainly because they maintained an underweight in Financials, the best performing sector. Consequently, the combined weighted return of the funds in the Canadian equity component underperformed the S&P/TSX Composite Index over the period.

The global equity market, represented by the MSCI World Index, gained 6.8% in U.S. dollars and 10.3% in Canadian dollars as Canadian investors benefited from a weaker loonie. Global value stocks outperformed global growth stocks as the MSCI World Value Index (C\$) gained 14.7% compared to 6.4% for the MSCI World Growth Index (C\$). U.S. equities outperformed international equities as the Standard & Poor's 500 Index (C\$) gained 11.3% compared to 9.1% for the MSCI EAFE Index (C\$). For the period, all of the funds in the global equity component underperformed the index. The strongest returns came from Dynamic Global Value Fund and Dynamic U.S. Dividend Advantage Fund, followed closely by Dynamic Global Equity Fund and Dynamic Global Dividend Fund which had solid positive returns but underperformed the index mainly because they maintained an underweight in U.S. Financials, the best performing sector. Dynamic Power Global Growth Fund's portfolio of growth stocks underperformed due to unfavourable security selection in Information Technology and Health Care as investors favoured value over growth stocks, while Dynamic Blue Chip Equity Fund lagged due to unfavourable security selection in Financials and Consumer Staples.

The Fund's net asset value increased by 38.8% to \$179.7 million at December 31, 2016, from \$129.5 million at June 30, 2016. This change was composed of net sales of \$50.0 million, investment performance of \$0.8 million and cash distributions of \$0.6 million. The investment performance of the Fund includes income and expenses which vary year over year. The Fund's income and expenses changed compared to the previous year mainly as a result of fluctuations in average net assets, portfolio activity and changes in the Fund's income earning investments.

Certain series of the Fund, as applicable, may make distributions at a rate determined by the Manager from time to time. If the aggregate amount of distributions in such series exceeds the portion of net income and net realized capital gains allocated to such series, the excess will constitute a return of capital. The Manager does not believe that the return of capital distributions made by such series of the Fund have a meaningful impact on the Fund's ability to implement its investment strategy or to fulfill its investment objective.

Recent Developments

IFRS 9, Financial Instruments

The final version of IFRS 9, Financial Instruments was issued by the International Accounting Standards Board ("IASB") in

July 2014 and will replace IAS 39, Financial Instruments: Recognition and Measurement, related to the classification and measurement of financial assets and financial liabilities.

IFRS 9 relates to the classification and measurement of financial assets and financial liabilities in the Fund. The new standard is effective for the Fund for its fiscal year beginning July 1, 2018. The Fund is evaluating the impact of this standard on its financial statements and will amend disclosures if required in the financial statements following the effective date.

Related Party Transactions

The Manager is a wholly-owned subsidiary of The Bank of Nova Scotia (“Scotiabank”). Scotiabank also owns, directly or indirectly, 100% of Scotia Securities Inc., HollisWealth Advisory Services Inc. and Tangerine Investment Funds Limited, each a mutual fund dealer, and Scotia Capital Inc. (which includes HollisWealth, ScotiaMcLeod and Scotia iTRADE), an investment dealer.

The Manager, on behalf of the Fund, may enter into transactions or arrangements with other members of Scotiabank or certain other companies that are related or connected to the Manager (each a “related party”). All transactions between the Fund and the related parties are in the normal course of business and are carried out at arm’s length terms.

The purpose of this section is to provide a brief description of any transaction involving the Fund and a related party.

Management Fees

The Manager is responsible for the day-to-day management and operations of the Fund. Certain series of the Fund pay the Manager a management fee for its services as described in the “Management Fee” section later in this document. The management fee is an annualized rate based on the net asset value of each series of the Fund, calculated and paid monthly.

Fixed Administration Fees and Other Fund Costs

The Manager pays the operating expenses of the Fund, other than Other Fund Costs, in exchange for the payment by the Fund of a fixed rate administration fee (the “Fixed Administration Fee”) to the Manager with respect to each series of the Fund. The expenses charged to the Fund in respect of the Fixed Administration Fee are disclosed in the Fund’s financial statements. The Fixed Administration Fee is equal to a specified percentage of the net asset value of a series, calculated and paid in the same manner as the management fees for the Fund. Further details about the Fixed Administration Fee can be found in the Fund’s most recent simplified prospectus.

In addition, each series of the Fund is responsible for its proportionate share of certain operating expenses (“Other Fund Costs”). Further details about Other Fund Costs can be found in the Fund’s most recent simplified prospectus.

The Manager, at its sole discretion, may waive or absorb a portion of a series’ expenses. These waivers or absorptions may be terminated at any time without notice.

Distribution Services

Certain registered dealers through which units of the Fund are distributed are related parties to the Fund and the Manager. The Manager pays to these related parties a trailer commission out of its management fees, representing distribution and servicing fees, based on the amount of assets held in the investors’ accounts. These fees are paid on the same basis and at the same rates that the Manager pays to non-affiliated dealers.

Other Fees

The Manager, or its affiliates, may earn fees and spreads in connection with various services provided to, or transactions with, the Fund, such as banking, brokerage, foreign exchange and derivatives transactions. The Manager, or its affiliates, may earn a foreign exchange spread when unitholders switch between series of funds denominated in different currencies.

Independent Review Committee

The Manager has established an independent review committee (the “IRC”) in accordance with National Instrument 81-107 – Independent Review Committee for Investment Funds (“NI 81-107”) with a mandate to review and provide recommendations or approval, as required, on conflict of interest matters referred to it by the Manager on behalf of the Fund. The IRC is responsible for overseeing the Manager’s decisions in situations where the Manager is faced with any present or perceived conflicts of interest, all in accordance with NI 81-107.

The IRC may also approve certain mergers between the Fund and other funds, and any change of the auditor of the Fund. Subject to any corporate and securities law requirements, no securityholder approval will be obtained in such circumstances, but you will be sent a written notice at least 60 days before the effective date of any such transaction or change of auditor. In certain circumstances, securityholder approval may be required to approve certain mergers.

The IRC has five members, Carol S. Perry (Chair), Brahm Gelfand, Simon Hitzig, D. Murray Paton and Jennifer L. Witterick, each of whom is independent of the Manager.

The IRC prepares and files a report to the securityholders each fiscal year that describes the IRC and its activities for securityholders as well as contains a complete list of the standing instructions. These standing instructions enable the Manager to act in a particular conflict of interest matter on a continuing basis provided the Manager complies with its policies and procedures established to address that conflict of interest matter and reports periodically to the IRC on the matter. This report to the securityholders is available on the Manager’s website or, at no cost, by contacting the Manager.

The compensation and other reasonable expenses of the IRC will be paid out of the assets of the Fund as well as out of the assets of the other investment funds for which the IRC may act as the independent review committee. The main components of compensation are an annual retainer and a fee for each committee meeting attended. The chair of the IRC is entitled to an additional fee. Expenses of the IRC may include premiums for insurance coverage, travel expenses and reasonable out-of-pocket expenses.

The Fund received the following standing instructions from the IRC with respect to related party transactions:

- Paying brokerage commissions and spreads to a related party for effecting security transactions on an agency and principal basis on behalf of the Fund;
- Purchases or sales of securities of an issuer from or to another investment fund managed by the Manager;
- Investments in the securities of issuers for which a related underwriter acted as an underwriter during the distribution of such securities and the 60-day period following the completion of such distribution;
- Executing foreign exchange transactions with a related party on behalf of the Fund;
- Purchases of securities of a related party;
- Entering into over-the-counter derivatives on behalf of the Fund with a related party;

- Entering into securities lending transactions with a related party;
- Outsourcing products and services to related parties which can be charged to the Fund;
- Acquisition of prohibited securities as defined by securities regulations;
- Trading in mortgages with a related party.

The Manager is required to advise the IRC of any breach of a condition of the standing instructions. The standing instructions require, among other things, that the investment decision in respect to a related party transaction: (a) is made by the Manager free from any influence by an entity related to the Manager and without taking into account any consideration to any associate or affiliate of the Manager; (b) represents the business judgment of the Manager uninfluenced by considerations other than the best interests of the Fund; and (c) is made in compliance with the Manager's written policies and procedures. Transactions made by the Manager under the standing instructions are subsequently reviewed by the IRC to monitor compliance.

The Fund did not rely on IRC standing instructions regarding related party transactions during the period.

(2) The management expense ratio is based on the total expenses of each series of the Fund, including sales tax and a proportionate share of underlying fund expenses (includes other mutual funds, ETFs and closed-end funds), where applicable, for the stated period and is expressed as an annualized percentage of daily average net asset value during the period. The MER excludes trading commissions and other portfolio transaction costs.

(3) The trading expense ratio represents total commissions and other portfolio transaction costs of the Fund and the underlying funds, where applicable, expressed as an annualized percentage of daily average net asset value of the Fund during the period.

(4) The Fund's portfolio turnover rate indicates how actively the Fund's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to Fund buying and selling all of the securities in its portfolio once in the course of the period. The higher a fund's portfolio turnover rate in a period, the greater the trading costs payable by the fund in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

Management Fee

The management fee is an annualized rate based on the net asset value of each series of the Fund, calculated and paid monthly. The management fees cover the costs of managing the Fund, arranging for investment analysis, recommendations and investment decision making for the Fund, arranging for distribution of the Fund, marketing and promotion of the Fund and providing or arranging for other services.





Past Performance
