 - (i) The Data Transmission Service is provided "AS IS" with no warranties expressed or implied of any kind, including, without limitation, any guarantee that information is accurate or complete or current at all times or the implied warranties of merchantability, fitness for a particular purpose and/or non-infringement. The Bank and its third party providers that support the Data Transmission Service are not responsible for any errors or omissions, or for the results obtained from the use of this Service.
 - (ii) Data downloaded or otherwise obtained from the Data Transmission Service shall be derived from transaction and other data obtained from various sources. The accuracy of data and reports generated using the Data Transmission Service depends upon the accuracy of the data received by Scotiabank including from you and Scotiabank's Third Party provider that supports the Service or that you the Company engage to support the Service on your behalf.

FAQ

What is the completion time for a setup? Target completion is 10-12 business days from when the form is correct & complete with a successful test connection from Visa to the endpoint. Additional time will be needed for FTPS implementations.

Can we provide a URL to a location to pick up the PGP key? We require the PGP key to be attached directly to the form.

What IPs will Visa transmit from? 198.241.175.62, 198.241.175.64

What is your default port? 22

Can I use a different port from 22? Yes, however this will significantly increase the setup time.

Where can I include information I want to share when there is no specific field? Use the notes field to provide any information that doesn't have a dedicated field or when you want to convey additional information/clarification.

What if I have more than 4 companies going to the same endpoint? You can add the additional companies in the notes field. Just be sure to provide the Company ID AND Company Name for each additional company.

How do I know if the given IP addresses on the form in the Submission Checklist have been whitelisted?

Check with the endpoint receiving the files. They will need to add them to allow us to access their server through these addresses.

How do I know if Read/Write access has been granted for the provided Delivery Directory? Check with the endpoint receiving the files to ensure the credentials provided allow access to the folder we are dropping the file off at.

Can you pull the PGP key used in a previous setup and that if it's going to the same endpoint? We request to always attach the PGP key to each request to ensure the correct key is used and we can refer back to that key in the future if there is a need to know what key was used.

If I don't have all the necessary information to complete the form, can I just fill in random information and get the correct information to you later? No, please do not submit a form with invalid data as a temporary placeholder. If you have questions about a field, please contact your CCS Support representative.

Definitions by Section

Issuer/Company Information

Issuer – A financial institution or entity partnership that issues Visa credit cards.

Processor – This is a company that is directly connected to VisaNet and provides Authorization, Clearing, Settlement, or payment - related processing services for Issuers or Merchants.

Issuer ID – An identification number used to identify an Issuer, also known as a Bank ID. Processor ID – An identification number assigned to a Processor such Total Systems or First Data.

Endpoint Information

3rd Party – A company receiving transaction data on behalf of the Issuers Client. 3rd Parties much be PCI Compliant if cardholder details are not masked.

Delivery Channel Information

Multi-Byte Encoding - The support of multibyte character sets for non - European characters.

VCF – Visa Commercial File – The standard file format designed by VISA containing card transactions, merchant details and other transaction activity information.

VCF Fixed Length - Tab delimited with fields padded to maintain field length.

VCF Variable Length - Tab delimited without field padding.

VCF Multi-Byte Variable Length – Tab delimited without field padding that supports inbound and outbound of non-European characters such as Japanese or Chinese.

Visa IntelliLink Data Solutions – An application that allows users to send the standard VCF or customize outbound file formats. If you are interested in this product please contact your support Account Manager or contact CCSSUPPORT@VISA.COM.

Extract A - An extract format that contains airline transactions only.

SAP R/3 – A format structured to load into a SAP ERP application. For file specifications please contact your SAP representative.

T11 - The billing period record within the VCF that defines closing date for an ending period and open date for the coming period.

Endpoint Connectivity Protocol

SFTP - Secure File Transfer Protocol - Allows secure transfer of data over networks.

FTPS - File Transfer Protocol Secure - Allows secure transfer of data over networks with SSL digital certificate.

SSL - Secure Sockets layer - The standard security technology for establishing an encrypted link.

SSH – Secure Socket Shell – An encrypted network protocol to allow remote login using a digital certificate or key. Visa provides this key to clients who wish to use this option.

PGP/GPG - Pretty Good Privacy/GNU Privacy Guard - A security key used to encrypt or decrypt data.
