DEFINITIONS

The following definitions apply to these Terms and Conditions:

"Eligible" refers to any individual qualified to participate in this contest.

"Individual" means a person who has entered the contest during the Promotional Period.

"Promotional Period" means from November 1st, 2018 to January 11th, 2019, inclusive.

"Promotion" refers to the Scotia Plan Loan Holiday Campaign 2018 and not any of The Bank's other promotions or programs.

"Prize" refers to the Campaign Prizes set out at clause 7 below of these Terms and Conditions

"Account" refers to Scotia Plan Loans, Mortgages, credit cards, Scotia Line or any other credit product of the Bank

"The Bank" or **"Scotiabank"** means Scotiabank Trinidad and Tobago Limited.

As part of the Promotion, Eligible customers purchasing a new motor vehicle from Massy Motors Ltd. shall receive up to TTD\$5,000.00 cashback which will go towards covering fees associated with their Scotia Plan Loans when they purchase a new vehicle from Massy Motors Limited.

ELIGIBILITY

The Promotion is open to legal residents of Trinidad and Tobago, 18 years of age or older with the exception of Scotiabank employees and/or those living in the same household of Scotiabank employees, their immediate families (spouses, parents, children and siblings and their respective spouses), as well as any of Scotiabank's partner companies, subsidiaries and/or its advertising agency Valdez and Torry International and their immediate families.
