

LATAM Market Update

- **Mexico: 1Q19 s.a. GDP downwardly revised and trade balance registered an unanticipated surplus**

Revised GDP for 1Q19 exhibited a lower annual real growth (+1.2%) than the preliminary figure (+1.3%). This result confirms our view that an adverse environment continued for the economic activity, as some factors such as the low investment flows associated with the high degree of uncertainty; the possible lower external demand; and the deceleration of consumption and labor market, remain weak. By components, services sector growth slowed down to 1.9% y/y (vs. +2.7% in 4Q18), industrial production posted a lower y/y decline of 0.7% (vs -0.9% in 4Q18), and agriculture growth rose +5.8% (vs. +3.1% in 4Q18). Furthermore, on a seasonally adjusted basis, quarterly GDP growth presented a decrease of 0.2%, just as was estimated in the preliminary figure, and the figure for 4Q18 was downwardly revised to 0.0% from 0.2% q/q.

Regarding April's trade balance, figures reported an unexpected USD \$1.37 billion surplus (vs. USD \$544 million deficit anticipated by the market consensus). In the breakdown, both exports and imports bounced back: exports increased 6.1% (vs. -1.2% in the previous month) y/y and imports rose 1.6% y/y (vs -0.5% previously). So far this year, the trade balance exhibits a USD \$446 million deficit.
