

LATAM Market Update

- **Mexico: Private consumption stuck at weak levels**

In May, private consumption growth marginally accelerated to 0.2% y/y, after remaining static in April. However, during the January–May period, household spending eased to 1.0% y/y, the slowest pace for a similar period since 2009. Consumption of domestic goods and services grew a small 0.3% y/y (vs. -0.1% in April), while that of imported goods fell by 0.1%, after increasing 1.0% in the previous month. On a seasonally adjusted basis, private consumption declined by 0.2% m/m, down from +1.1% in April. The domestic component decelerated to 0.1% from 0.4%, while the imported one dropped by 1.8% on the heels of a 5.2% expansion.

These figures are consistent with both the recent softening in labor market conditions and the weakening consumer credit dynamics. In our assessment, heightened uncertainty and undermined consumer confidence stemming from unpredictable policymaking under the new government are likely to continue to have a negative impact on household spending during the rest of the year. However, this might be partially offset by the rapid wage growth and still-strong remittances inflows.
