1832 Asset Management L.P. is the manager (the "Manager") of the fund. In this document, "we", "us", "our" and the "Manager" refer to 1832 Asset Management L.P. and the "Fund" refers to Scotia Emerging Markets Equity Index Tracker ETF.

The term "net asset value" or "net asset value per unit" in this document refers to the net asset value determined in accordance with Part 14 of National Instrument 81-106 — Investment Fund Continuous Disclosure ("National Instrument 81-106"); while the term "net assets" or "net assets per unit" refers to total equity or net assets attributable to unitholders of the Fund as determined in accordance with IFRS Accounting Standards.

Investment Objective and Strategies

The Fund seeks to replicate, to the extent possible and before fees and expenses, the performance of a broad equity market index that tracks the investment returns of publicly traded securities issued by large and mid capitalization companies in the emerging markets. Currently, the Fund seeks to replicate Solactive GBS Emerging Markets Large & Mid Cap Index.

Risk

The risks associated with investing in the Fund are as described in the simplified prospectus. There were no material changes to the Fund during the period that affected the overall level of risk of the Fund.

Results of Operations

For the year ended December 31, 2024 (the "period"), the Fund generated a total return of 16.2%. Fund returns are reported net of all management fees and expenses, unlike the returns of the Fund's benchmark, which is based on the performance of an index that does not pay fees or incur expenses.

The Fund's broad-based benchmark, Solactive GBS Emerging Markets Large & Mid Cap Index (CA NTR) returned 17.4% during the same period. In accordance with National Instrument 81-106, we have included a comparison to this broad-based index to help you understand the Fund's performance relative to the general performance of the market.

For the period ended at December 31, 2024 (the "period"), the Scotia Emerging Markets. Equity Index Tracker ETF (the "Fund") generated a total return of 16.2%. The Fund's broad-based

benchmark, Solactive GBS Emerging Markets Large & Mid Cap Index (CA NTR), rose 17.4%.

The Fund underperformed the benchmark, the under performance resulted primarily from management fees and other operating expenses.

2024 proved to be another strong year for global equity markets, while US growth showed resilience, China's slowdown continued, and Eurozone growth remained weak. Inflation lowered toward central bank target levels, paving the way for lower interest rates with most major central banks delivering cuts over the second half of the year.

Arguably, one of the most significant developments in 2024 was China's shift in policy stance. Chinese equities had suffered a multiyear period of weakness coming into 2024, due to factors including, strict Covid-19 policies, declining real estate prices and lower consumer sentiment. A key concern had been the government's insufficient policy response to these challenges, but in September, China introduced a large-scale monetary stimulus, targeted directly at real estate and equity markets.

India, meanwhile, enjoyed solid economic performance in 2024, benefiting from the reform driven Prime Minister Modi's focus on infrastructure investment and a growing middle class. Economic growth has exhibited some of the highest rates among emerging markets and political risk appears relatively low, with Modi maintaining high approval ratings.

Taiwan was one of the strongest major markets during period, benefiting from a cyclical recovery in semiconductor demand, but more importantly the emergence of Artificial Intelligence (AI) as a durable demand driver. The return of the Taiwan market was dominated by chip maker Taiwan Semiconductor Manufacturing Corporation, which is the largest holding in the Index.

South Korea, another tech heavy market faced challenges in 2024 as Samsung Electronics' struggles with AI memory technology, led to market declines for the year. Nevertheless, the Korean government's "Value Up" agenda encouraged companies to take action to improve their valuations through a greater focus on profitability, and capital returns to minority shareholders. However, political instability in the wake of now impeached President Yoon's peculiar decision to briefly declare martial law has raised questions about the durability of the agenda, amongst others.

China, Taiwan, India and South Korea account for over 70% of the Index.

In Central and South America, both the Mexican and Brazilian markets endured declines, in each case partly driven by politics which weighed on currency returns. In Mexico, a negative reaction to the Presidential election raised fears of a more radical agenda which was compounded by the fear of raised tariffs under President Trump.

The Brazilian market endured significant volatility, as concerns mounted over President Lula's proposed spending policies and a protracted budget approval impasse in congress. This led to a sharp depreciation of the Brazilian Real, further compounding local market weakness.

Nine of 11 GICS (Global Industry Classification Standard) sectors posted positive returns over the 12-month period. The best performing sectors were Information Technology, Consumer

Discretionary, and Financials. The worst performing sectors were Materials, Consumer Staples, and Energy.

The Fund's net asset value increased to approximately \$126.7 million at December 31, 2024 from \$102.4 million at December 31, 2023. This change was composed of net investment performance of \$16.5 million, net sales of \$10.9 million and cash distributions of \$3.1 million. The investment performance of the Fund includes income and expenses which vary year over year. Prior year results are not available for comparative purposes as the Fund commenced operations during the current year.

The Fund may make distributions at a rate determined by the Manager from time to time. If the aggregate amount of distributions exceeds the portion of net income and net realized capital gains, the excess will constitute a return of capital. The Manager does not believe that the return of capital distributions made by the Fund have a meaningful impact on the Fund's ability to implement its investment strategy or to fulfill its investment objective.

Recent Developments

There have been no recent developments that have affected, or likely to materially affect the Fund.

Related Party Transactions

The Manager is a wholly-owned subsidiary of The Bank of Nova Scotia ("Scotiabank"). Scotiabank also owns, directly or indirectly, 100% of Scotia Securities Inc., a mutual fund dealer, and Scotia Capital Inc. (which includes ScotiaMcLeod and Scotia iTRADE), an investment dealer.

The Manager, on behalf of the Fund, may enter into transactions or arrangements with other members of Scotiabank or certain other companies that are related or connected to the Manager (each a "related party"). All transactions between the Fund and the related parties are in the normal course of business and are carried out at arm's length terms.

The purpose of this section is to provide a brief description of any transaction involving the Fund and a related party.

Management Fees

The Manager is responsible for the day-to-day management and operations of the Fund. The Fund pay the Manager a management fee for its services as described in the "Management Fee" section later in this document. The management fee is an annualized rate based on the net asset value of the Fund, accrued and calculated daily and paid monthly.

Fixed Administration Fees and Fund Costs

The Manager pays the operating expenses of the Fund, other than Fund Costs, in exchange for the payment by the Fund of a fixed rate administration fee (the "Fixed Administration Fee") to the Manager with respect to the Fund. The expenses charged to the Fund in respect of the Fixed Administration Fee are disclosed in the Fund's financial statements. The Fixed Administration Fee is equal to a specified percentage of the net asset value the Fund, calculated and paid in the same manner as the management fees for the Fund. Further details about the Fixed Administration Fee can be found in the Fund's most recent simplified prospectus.

In addition, the Fund is responsible for its proportionate share of certain operating expenses ("Fund Costs"). Further details about Fund Costs can be found in the Fund's most recent simplified prospectus.

The Manager, at its sole discretion, may waive or absorb a portion of a series' expenses. These waivers or absorptions may be terminated at any time without notice.

Designated Broker

Scotia Capital Inc., an affiliate of the Manager, is the designated broker of the Fund. As a designated broker, Scotia Capital Inc. may subscribe for or be issued units of the Fund by the Manager from time to time.

Independent Review Committee

The Manager has established an independent review committee (the "IRC") in accordance with National Instrument 81-107 — Independent Review Committee for Investment Funds ("NI 81-107") with a mandate to review and provide recommendations or approval, as required, on conflict of interest matters referred to it by the Manager on behalf of the Fund. The IRC is responsible for overseeing the Manager's decisions in situations where the Manager is faced with any present or perceived conflicts of interest, all in accordance with NI 81-107.

The IRC may also approve certain mergers between the Fund and other funds, and any change of the auditor of the Fund. Subject to any corporate and securities law requirements, no securityholder approval will be obtained in such circumstances, but you will be sent a written notice at least 60 days before the effective date of any such transaction or change of auditor. In certain circumstances, securityholder approval may be required to approve certain mergers.

The IRC has five members, Stephen J. Griggs (Chair), Steven Donald, Heather A. T. Hunter, Cecilia Mo and Jennifer L. Witterick, each of whom is independent of the Manager.

The IRC prepares and files a report to the securityholders each fiscal year that describes the IRC and its activities for securityholders as well as contains a complete list of the standing instructions. These standing instructions enable the Manager to act in a particular conflict of interest matter on a continuing basis provided the Manager complies with its policies and procedures established to address that conflict of interest matter and reports periodically to the IRC on the matter. This report to the securityholders is available on the Manager's website or, at no cost, by contacting the Manager.

The compensation and other reasonable expenses of the IRC will be paid out of the assets of the Fund as well as out of the assets of the other investment funds for which the IRC may act as the independent review committee. Each member of the IRC receives an annual retainer of 62,000 (77,000 for the Chair), plus

expenses for each meeting. The fees and expenses, plus associated legal costs, are split equally among all of the funds managed by the Manager for which the IRC acts as the independent review committee. The main component of compensation is an annual retainer fee. Prior to November 1, 2021, each IRC member also received a fee for each committee meeting attended. Expenses of the IRC may include premiums for insurance coverage, travel expenses and reasonable out-of-pocket expenses.

The Manager, in respect of the Fund, received the following standing instructions from the IRC with respect to related party transactions:

- Paying brokerage commissions and spreads to a related party for effecting security transactions on an agency and principal basis on behalf of the Fund:
- Purchases or sales of securities of an issuer from or to another investment fund managed by the Manager;
- Investments in the securities of issuers for which a related underwriter acted as an underwriter during the distribution of such securities and the 60-day period following the completion of such distribution;
- Executing foreign exchange transactions with a related party on behalf of the Fund;
- Purchases of securities of a related party;
- Entering into over-the-counter derivatives on behalf of the Fund with a related party;
- Outsourcing products and services to related parties which can be charged to the Fund;
- Acquisition of prohibited securities as defined by securities regulations;
- Trading in mortgages with a related party;
- Entering into a designated broker agreement with a related party; and
- Entering into a prime broker agreement with a related party.

The Manager is required to advise the IRC of any breach of a condition of the standing instructions. The standing instructions require, among other things, that the investment decision in respect to a related party transaction: (a) is made by the Manager free from any influence by an entity related to the Manager and without taking into account any consideration to any associate or affiliate of the Manager; (b) represents the business judgment of the Manager uninfluenced by considerations other than the best interests of the Fund; and (c) is made in compliance with the Manager's written policies and procedures. Transactions made by the Manager under the standing instructions are subsequently reviewed by the IRC to monitor compliance.

The Manager, in respect of the Fund, relied on IRC standing instructions regarding related party transactions during the period.

Financial Highlights

The financial highlights tables and the ratios and supplemental tables required to be presented in this section is intended to help understand the Fund's financial performance for the period indicated. The information on the following tables is based on prescribed regulations and as a result, is not expected to add across due to the increase (decrease) in net assets from operations being based on average units outstanding during the period and all other numbers being based on actual units outstanding at the relevant point in time. - (2) The management expense ratio is based on total expenses (including sales tax, and excluding commissions and other portfolio transaction costs) of the Fund and a proportional share of underlying funds' expenses (mutual funds, ETFs and closed-end funds), where applicable, for the stated period and is expressed as an annualized percentage of the daily average net asset value during the period.
- (3) The trading expense ratio represents total commissions and other portfolio transaction costs of the Fund and the underlying funds, where applicable, expressed as an annualized percentage of daily average net asset value of the Fund during the period.
- (4) The Fund's portfolio turnover rate indicates how actively the Fund's portfolio advisor manages its portfolio investments. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

Management Fees

The management fee is an annualized rate based on the net asset value of the Fund, accrued and calculated daily and paid monthly. The management fees cover the costs of managing the Fund, arranging for investment analysis, recommendations and investment decision making for the Fund, arranging for distribution of the Fund, marketing and promotion of the Fund and providing or arranging for other services.



Index Descriptions

Solactive GBS Emerging Markets Large & Mid Cap Index (CA NTR) — The index intends to track the performance of the large and mid cap segment covering approximately the largest 85% of the free-float market capitalization in the Emerging Markets. The Index is calculated as a CA net total return index in Canadian dollars and is rebalanced quarterly.

A discussion of the performance of the Fund as compared to its benchmarks is found in the Results of Operations section of this report.
